

# **Housing Break Fees and Payment Schedule**

Summer and winter break accommodations are **not included** in the on-campus comprehensive fee. Students wishing to stay on campus during summer and winter breaks have to pay for their housing separately. The fees for staying on campus over winter and summer break may change on an annual basis and it does not include a meal plan. Each break is divided into set intervals and students will be billed for the entirety of the interval regardless of whether they remain on campus for the entirety or part of the interval. It is necessary to streamline checkout processes in order to support our cleaning and maintenance staff. We are unable to accommodate students checking in and out at other intervals throughout breaks. The dates for each break's intervals are listed below.

### **Application Deadlines**

Remaining on campus for the summer or winter breaks will be subject to limited availability and requires advance application. Students who are approved to live on campus over breaks may be required to fully vacate their room and relocate to another room or building at the discretion of Residential Life & Housing.

#### Winter Deadline

The deadline for applying for winter housing is **November 1,2024 at 5pm**. The application form for 2024-25 winter housing will be available in the fall 2024 semester.

#### **Summer Deadline**

The deadline for applying for summer housing is **Friday, March 14, 2025 at 9am**. Students must complete the application prior to this date. Students will be notified after the deadline about whether they have been accepted to stay on campus over break.

### **Billing and Payment Methods**

Those who are approved to stay on campus over break will be notified by Student Accounts regarding their bill. For payment methods, please see our website for more details and always state your name + Summer/Winter Housing when making your payment. Failure to pay by the due date will result in cancellation of your break housing contract.
