FA319 Advanced Drawing: Process and Experimentation

Course Description

This advanced drawing course emphasizes process-based and experimental drawing. Through prompts, students will deepen their understanding of different relationships that open up when drawing: the interplay between the agency of materials and the manipulation of these through the use of tools, the connection of drawing to the (moving) body, as well as the limitation of and interaction with the boundaries of a page and the surrounding space. In the latter part of the course, the focus will shift towards reflecting on and editing (elements of) the drawings. This will be coupled with the exploration of different ways of installing drawing in space, considering the relationship to the viewer. Overall, this course embraces personal experiences, prioritizing making over the final image. The objective is to build toward an embodied knowledge that will serve as the foundation for individual and group conversations. The conversations will be supplemented with visual examples and artists' writings on the given subject. Students should have prior drawing experience, curiosity, and a willingness to un- and relearn. By the end of the semester, each student will have the opportunity to present their drawings through a self-curated presentation or an installation at Monopol during the BCB Open Studios.

Requirements

Students are expected to:

- Turn off phones during class time.
- Initiate appointments with the Professor or arts staff outside of class time.
- Always allocate extra time for work preparation and clean-up for independent production.
- Respond to emails from their professors in a timely manner.
- Inform their professors at the beginning of the semester if photos of student's identity, artwork, works in progress are NOT to be taken and / or used for Bard College Berlin.

Assessment

Assignments are due at the beginning of the class. Detailed information about assignments and projects will be explained in class. (Assignments and the dates described in this syllabus may be subjected to change by the instructor. Students will be notified of any changes to the syllabus in class.)

Basic art materials will be provided. Please be aware that some materials may need to be purchased directly by each student at their own expense, depending on the requirements for the personal project.

Policy on Late Submission of Artworks / Presentations

Assignments (artworks, essays, performances, oral presentations) that are up to 24 hours late will be downgraded one full grade (Example: B+ becomes C+). The Professor is not obliged to accept assignments that are more than 24 hours late. Where a professor agrees to accept a late assignment, it should be submitted by the new deadline agreed upon by both parties. Thereafter, the student will receive a failing grade for the assignment. Grades and comments will be returned to students in a timely fashion. Students may make an appointment to discuss assignments and feedback during instructors' office hours.

Students receive mid- and end-of-semester grades for their seminar work. Students are entitled to make an appointment with an instructor to discuss seminar participation, or may be asked to meet with the instructor at any stage in the semester regarding class progress.

Grade Breakdown

Students will receive a midterm grade based on the execution of the given prompts and the accompanying assignments. The final grade will be based on the development and execution of the personal project. Grading of the work will reflect the ambition, effort, and quality. The work will form 70% of your midterm- and final grade

Additionally, students are assessed on their ability to work together in collaborative and independent projects. 30% of your midterm- and final grade will be based on attendance and active participation in class activities such as discussions, critiques and the execution of the prompts.

Policy on the use of facilities:

- 1. The Factory (Eichenstrasse 43) and Monopol (Provinzstr 40-44) at BCB offer space and facilities to BCB art students. Chip access is from 7 a.m. to 10 p.m. every day, including the weekends during the semester. The buildings cannot be used outside these hours.
- 2. Fire exits and lanes must be kept clear of any obstructions.

- 7. All work surfaces (indoor and outdoor) must be adequately protected with the workshop's drop cloth before spray painting or working with plaster.
- 8. During completion week, any space used by a student must be emptied, with clean walls and floors. All garbage must be adequately disposed of. Final grades may be affected or withheld if any item remains by the inspection deadline.
- 9. When leaving the building, students must ensure all lights are turned off, all electrical items must be unplugged, and doors must be closed.
